Chris to send Clinton Diverter Letter on Letterhead. Chris moved. Linda seconded. Discussion: Division Street Count? Outreach to Division and Ladd residents too, vote: unanimous.

Chris to send Commercial Residential (CR) Zoning Letter on Letterhead. Chris moved. Jessica seconded. Discussion: Request the CR zoning to apply to both Single Family and Multifamily residential. Adopt present non-conforming use protections for CR Zoning. Height to reflect the surrounding buildings and FAR (floor to area ratio) calculations, vote: unanimous.

Chris to finish letter Multifamily R2 zoning changing to R1 within a Quartermile from both Clinton and Rhine max stations. Linda moved Chris seconded. Discussion: quarter mile is measured as the "crow flies" but these stations are not presently easily accessible due to the Heavy and Light rail tracks. 20th and Taggart the infrastructure does not exist (i.e. sewer). Vote: 6 yes 1 abstained.
